The Minister of Health of the Republic of Serbia, deciding upon the application of the company "INO-PHARM" d.o.o., Belgrade, Bore Stankovića Str. No. 2, for the issuance of a wholesale distribution authorisation for medicinal products, pursuant to Article 212, Paragraph 6 of the Medicines and Medical Devices Act ("Official Gazette of the Republic of Serbia", No. 30/2010, 107/2012, 105/2017 – other law and 113/2017 – other law), Article 37 of the Law on Inspection Oversight ("Official Gazette of the Republic of Serbia", No. 36/2015, 44/2018 – other law and 95/2018), and Articles 136 and 184 Paragraphs 1 and 2 of the General Administrative Procedure Act (Official Gazette of the Republic of Serbia No. 18/2016 and 95/2018-authentic interpretation), passes the following

DECISION

I The trade and services company "INO-PHARM" d.o.o., Belgrade (Čukarica), Bore Stankovića Str. No. 2, IS GRANTED AN AUTHORISATION for the wholesale distribution – import, export, supply, storage and distribution of medicinal products on the territory of the Republic of Serbia, from the office and storage premises with a total area of 250.50 m² in Belgrade (Čukarica), Bore Stankovića Str. No. 2, of the following:

1. Medicines for human use in accordance with the ATC (Anatomical Therapeutic Chemical) classification of the following main anatomical groups:

- **Group A** Medicines affecting digestive and metabolic diseases
- **Group B** Medicines for the treatment of diseases of blood and blood-forming organs
- **Group C** Medicines affecting the cardiovascular system
- **Group D** Medicines for the treatment of diseases of skin and subcutaneous tissue
- **Group G** Medicines for the treatment of the genitourinary system and sex hormones
- **Group H** Systemic hormonal preparations
- **Group J** Anti-infectives for systemic use
- Group L Antineoplastic and immunomodulating agents
- Group M Medicines for the diseases of the musculoskeletal system
- **Group N** Medicines affecting the nervous system
- **Group P** Antiparasitic products, insecticides and repellents
- Group R Medicines for the treatment of respiratory tract diseases
- **Group S** Medicines affecting the eye and the ear
- Group V Other therapeutic products (excluding medicines in the main therapeutic groups V09 and V10).

II The AUTHORISATION issued by the Ministry of Health, number 515-04-06623/2021-11 of July 30th, 2021 IS REVOKED.

Grounds for the decision

The company "INO-PHARM" DOO Belgrade, was issued the Decision by the Ministry of Health, number 515-04-06623/2021-11 of July 30th, 2021, with the wholesale distribution authorisation for medicinal products from the office and storage space in Belgrade, at the address Bore Stankovića Str. No. 2.

On December 29th, 2021, the company "INO-PHARM" DOO Belgrade, due to the extension of its storage facilities, submitted a request to the Ministry of Health for the issuance of a new wholesale distribution authorisation – import, export, supply, storage and distribution of medicinal products on the territory of the Republic of Serbia, from the office and storage premises with a total area of 250.50 m² in Belgrade (Čukarica), Bore Stankovića Str. No. 2, for medicinal products for human use in accordance with the ATC (Anatomical Therapeutic Chemical) classification for all the main anatomical groups, herbal medicines, traditional medicines, homoeopathic medicines and clinically tested medicines. The application was accompanied by the necessary supporting evidence.

Acting upon the submitted request, pursuant to Article 208, Paragraph 3, Item 2) of The Medicines and Medical Devices Act (Official Gazette of the Republic of Serbia, No. 30/2010, 107/2012, 105/2017 – other law and 113/2017 – other law), the medicinal products and medical devices inspector performed an inspection of the space and equipment for storage of medicinal products, the inspection of the vehicles, as well as verification of compliance with requirements regarding the employees qualifications as set out in the protocol of the inspection number 515-04-11536/2021-11 dated February 3rd 2022.

Based on the inspector's protocol and the submitted documentation, it has been determined that the requirements for the performance of wholesale distribution of medicinal products stipulated by the Medicines and Medical Devices Act (Official Gazette of the Republic of Serbia, No. 30/2010, 107/2012, 105/2017 – other law and 113/2017 – other law), and Article 3, Article 8 Paragraph 1, Item 1), Articles 9, 10, 11, 15. Paragraph 1, Items 1), 2) and 3), Article 19, Article 24, Paragraph 5 and Article 30 of the Regulations on Requirements for Wholesale Distribution of Medical Devices, the data entered into the Register of issued authorisations for wholesale distribution of medicinal products and medical devices, as well as the method of entry (Official Gazette of the Republic of Serbia No. 10/2012, 17/2017 and 84/2018 – other law). Medical devices will also be stored in the same space, but they will be organizationally separated.

By passing this Decision, the Decision issued by the Ministry of Health, No. 515-04-06623/2021-11 dated July 30th, 2021 is revoked.
